## I. SCHOOL READINESS & VPK ATTENDANCE SUBMISSION PROCESS

• DUE DATE: April 3, 2020

#### **School Readiness:**

- Mark the first 3 absences for each SR child as an 'A'
- Mark all additional absences beyond the 3 with a 'D' IMPORTANT: absences related to COVID-19 in any way (parent laid off from work, potential exposure, being precautious, etc.) need to have the comment "Absence due to Disaster" under the reason.
- ➤ Doctors Notes for absences related to COVID-19 are NOT required.
- Complete this process for ALL ENROLLED School Readiness Children for the month of March 2020
- If the child transferred to another site, you can only claim them through the last day of attendance.
- Sign in/out sheets should be uploaded as usual to BlueJean no additional notes needed.

#### VPK:

- Mark absences for each day your VPK program was open as you normally would.
- For Long or Short Forms: If you are unable to get the parent signature, write this on the form along with the reason the parent did not sign.
- Upload sign in/out sheets and Long or Short Forms as you typically would to BlueJean

### FOR PROVIDERS WHO CLOSED:

From March 1<sup>st</sup> until the date you voluntarily closed your site, follow these instructions above for each child enrolled

IMPORTANT: ENSURE YOU HAVE SUBMITTED YOUR NOTICE OF CLOSURE TO ME VIA EMAIL INCLUDING THE INFORMATION BELOW:

DO NOT SUBMIT YOUR ATTENDANCE UNTIL ELCMC STAFF CONTACTS YOU! ELCMC Staff have to process your closure notice before you can submit your attendance.

# II. PARENT FEE WAIVERS – **EFFECTIVE APRIL 1, 2020**

- ELCMC will be paying you the entire ELCMC approved Market Rate for each child enrolled in your program based on Provider Type, Child Age, and Child Eligibility (FT/PT)
- You MAY still charge SR parents ONLY your differential rate.

- You MAY NOT charge a parent their Parent Fee + Differential
- Differential Fees are REQUIRED to be listed on your private pay rate sheet uploaded to your Provider Profile.
- You can find the approved Market Rate in your SR Contract located in your Provider Profile.
